ANNUAL NOTIFICATION OF CARRYING ON OF A BUSINESS: BUSINESSES ACT, 1991(Act No.71 of 1991):

Dear Sir/ Madam

You are hereby advised that Regulation 15 under the business Act (Act No. 71 of 1991) states as follows:

15(1). not later than the last working day in December of each year the licensing authority shall post to every license holder a form on which such license holder is required to provide the following information=

- a) Confirmation that the business for which the license was issued is continuing to be conducted from the premises specified in the license and that no other business for which a license is required in terms of the Act is being conducted from the same licensed premises.
- b)
 - i. in the case of a registered company or close corporation, the full name and registered address of that company or close corporation.
 - ii. in every other case, the full name, postal address, street address and residential address of every person having propriety interest in that business
 - iii. in the case of the business referred to in item 2 of schedule 1 of the Act, the name of the person in actual and effective control of the business.

15(2) The complete and signed form contemplated in sub-regulation (1), shall be lodged with the relevant licensing authority by every license holder not later than 15:00 on the last working day of January in each year.

To enable you to comply with the foregoing requirement, kindly complete the form on the reverse side of this letter and return to this office.

Kindly note that failure to comply with the foregoing constitutes an offence and could render you liable for prosecution.

You are hereby advised that the business license Act No 71 of 1991 states as follows:

“(3). No person shall, with effect from the date specified in the notice under subsection(1) in respect of a specific licensing authority, carry on any business in the area of that licensing authority-

- a) Unless, in the case of a business referred to in item 1(1) or 2 of schedule 1, he/she is the holder of an apposite license issued to him/her by the licensing authority in respect of the business premises concerned.”

Please note that unless a response is received from you by no longer than 16:00 on, the council will have no option but to consider prosecuting you in terms of section 5 of the above Act which states as follows:-

“5. (1) any person who contravenes a provision of section2 (3) shall be guilty of an offence and liable on conviction:-

- (a) to a fine not exceeding R1 000 or imprisonment for a period not exceeding Three months, or both such fine or such imprisonment; and
- (b) to an additional fine of R 10 for every day on which the offence continues”
