

**TENDER NOTICE AND INVITATION TO TENDER

**TENDER NO:UMHL 12/2014/2015: SUPPLY, INSTALLATION COMMISSIONING AND  
HANDOVER OF THE ELECTRIFICATION OF 250 CONNECTIONS AT MBOZA AREA**

Tenders are hereby invited by the Umhlabuyalingana Local Municipality for the supply, installation, commissioning and handover of the electrification of 250 connections at Mboza near to Zamazama.

The detail with regards to the construction work in brief comprises the installation of MV, LV and house connections with Prepaid meters.

**All tenderers who wish to tender for this project must be 4EP or 4PE or higher CIDB Registered and registered on the Eskom Eastern Region Vendor List for Electrification.**

Tender documents can be obtained during office hours from the Umhlabuyalingana Local Municipality Offices at the compulsory clarification meeting. Please note that in order to obtain a Tender Document **a non-refundable deposit of R350.00 (either in cash or by bank guaranteed cheque made out to uMhlabuyalingana Municipality) is payable.** No documents will be handed out unless the Tenderer produces a receipt for the deposit.

Representatives of the Consulting Engineer will meet prospective Tenderers at **11h00 on Thursday the 26 February 2015** at the Umhlabuyalingana Local Municipality Offices for the **compulsory clarification meeting and then depart for the compulsory site inspection at Mboza Area.**

A person who is directly employed by the Tenderer and is suitably qualified and experienced to comprehend the implications of the work involved must represent the Tenderer at the tender meeting.

Sealed tenders clearly endorsed “ **TENDER NO:UMHL12/2014/2015: SUPPLY, INSTALLATION COMMISSIONING AND HANDOVER OF THE ELECTRIFICATION OF 250 CONNECTIONS AT MBOZA AREA**” must be placed in the Municipality’s tender box located in the foyer of Umhlabuyalingana Local Municipality, R22 Manguzi Main Road, before **13h00 on Thursday the 12 of March 2015.** Tender documents without complete pricing to ALL items listed in the Schedule of Quantities, will be disqualified.

This invitation is subject to the terms of the Umhlabuyalingana Local Municipality Preferential Procurement Policy and will be evaluated in terms of the 90:10 method as set out in the Preferential Procurement Policy Framework Act (No. 5 of 2000) Regulations. It is solely the responsibility of the Service Providers who desire to avail themselves of the preferences available under this policy to familiarize themselves with its contents and to comply with its conditions in order to be able to make any claim for preference. Copies of the Umhlabuyalingana Local Municipality Preferential Procurement Policy may be obtained from the office of the Chief Financial Officer.

The Umhlabuyalingana Local Municipality will not accept responsibility for late delivery of tenders by courier services or any other means that are not placed in the tender box on or before the date and time of the closing of the tender. The Umhlabuyalingana Local Municipality does not bind itself to accept the lowest or any tender and reserves the right to accept any tender in whole or in part.
